

Construction Alert

SE 16th Street Walkway Improvements

April 2020

Description

The Bellevue Transportation Department plans the following traffic safety improvements on SE 16th Street/SE Phantom Way, near Phantom Lake. The work will make it safer and more convenient for people to walk between the neighborhood and schools and will address vehicle speeds:

- Raised crosswalk on SE 16th Street at 160th Avenue SE.
- New sidewalk with curb and gutter on the south side of SE 16th Street, between 160th Avenue SE and the cul-de-sac. Sidewalk alignment chosen to minimize tree removal.
- Marked crosswalk across the SE 16th Street cul-de-sac connection to SE Phantom Way.
- Speed radar signs combined with school zone "20 mph when flashing" signs for eastbound and westbound directions. The existing radar sign will be removed.
- Pavement restoration.

What to expect

Construction is expected to begin in late April and be completed by fall 2020. Construction schedules are subject to change. Work is weather dependent.

- Work hours: 7 a.m. to 4 p.m., Monday through Friday.
- Traffic impacts: Intermittent lane closures.

Construction funding

Construction funding comes from the Neighborhood Safety, Connectivity and Congestion Levy and is estimated at \$430,000.

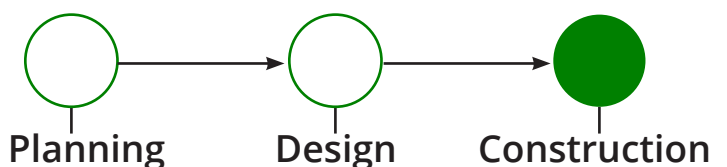

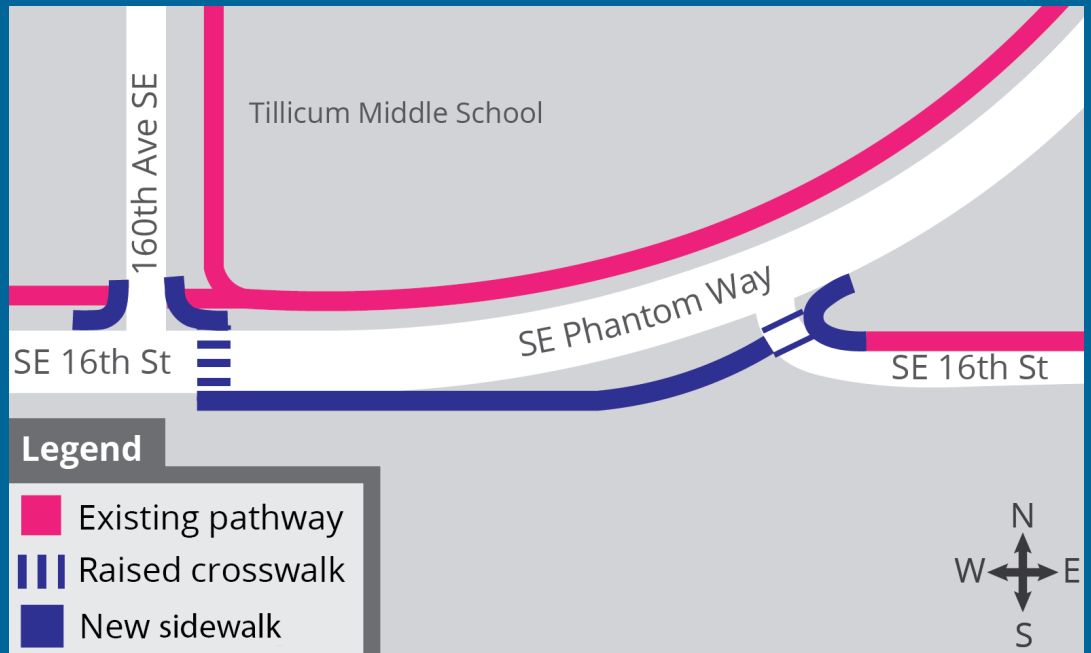
