156TH AVENUE SE BIKE LANES COMING SUMMER 2018

Bike Lanes – SE 24th St to Lake Hills Blvd

The City of Bellevue will install bike lanes in both directions along 156th Avenue SE from SE 24th Street to Lake Hills Boulevard in coordination with the Pavement Overlay Program and in accordance with Bellevue's Pedestrian & Bicycle Implementation Initiative. The bike lanes will include painted buffer areas south of the Lake Hills Greenbelt park entrance to improve safety for people bicycling by providing additional separation from motor vehicles.

No Parking Signs – SE 24th St to SE 16th St

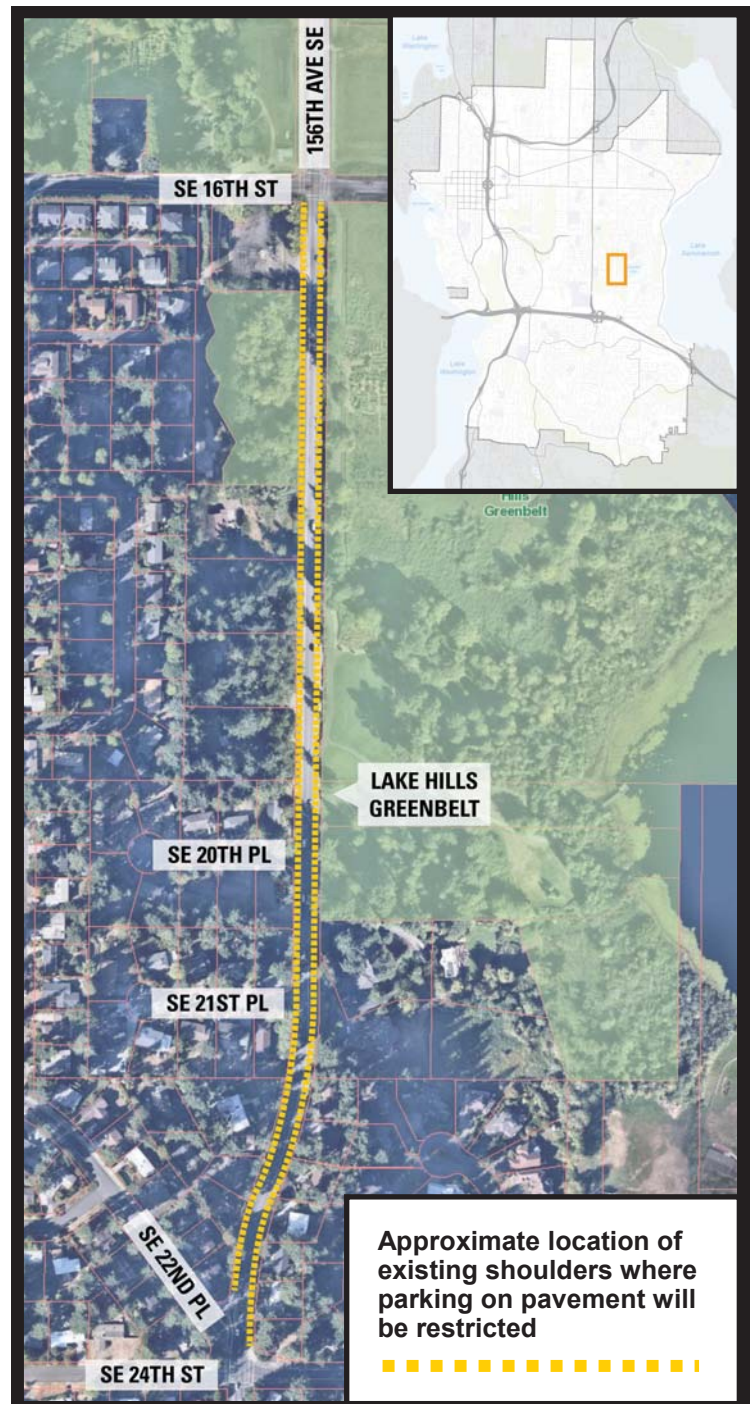
Together with the bike lanes, "No Parking On Pavement" signing will be installed on both sides of 156th Avenue SE, from SE 24th Street to north of SE 16th Street. The pavement parking restriction will be installed to keep the paved shoulders clear for people on bicycles at all times. Parking will still be permitted off-street where there is sufficient space to avoid blocking the bike lane.

Schedule:

Summer 2018: Pavement resurfacing, bicycle lane markings, and permanent "No Parking On Pavement" signs will be installed along 156th Avenue SE.

Approximate location of existing shoulders where parking on pavement will be restricted

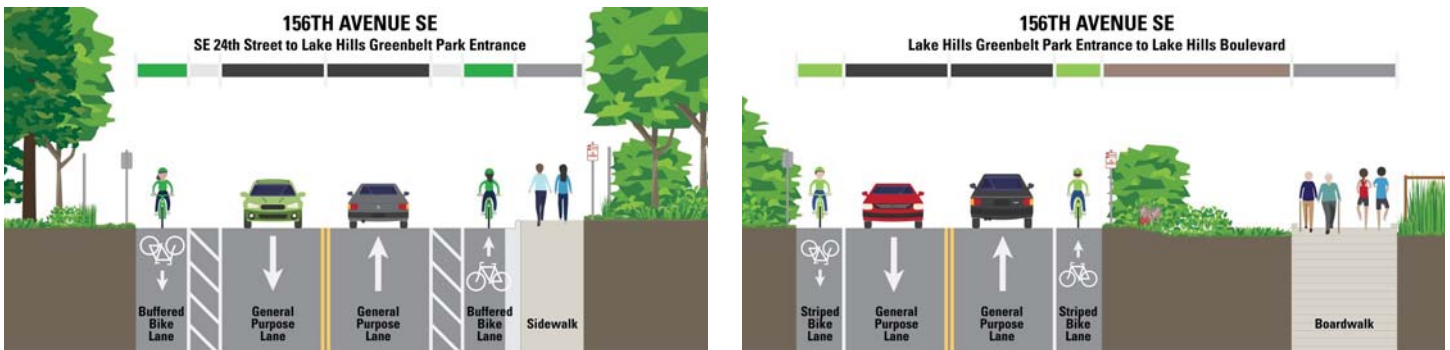
