- The operations fee is \$48 if plan review is required and \$13 if the permit is issued without plan review.
- ◆ This fee is charged if plan review is required.
- # Current fee: the actual fee depends on plat or PUD vesting.
- This plan review estimate is based on the fair market valuation of the labor and materials needed to do your project. Call Permit Processing for an estimate or read the fee table for valuation-based construction fees.
- ★ Fees for an Adult Family Home inspection with no construction are based on \$1,000 valuation.
- ⊖ Charged when the scope of work requires Clearing & Grading or Land Use Review.
- ♠ Charged when the scope of work requires Clearing & Grading Inspections.
- * Charged at issuance when the scope of work requires a Fire inspection.

Note: It is important to receive final inspection approval before your permit expires. If you do not, finals-only single family permits are: \$73 - Building; \$44 - Plumbing; \$51- Mechanical; \$69 - Electrical; \$66 - C&G
